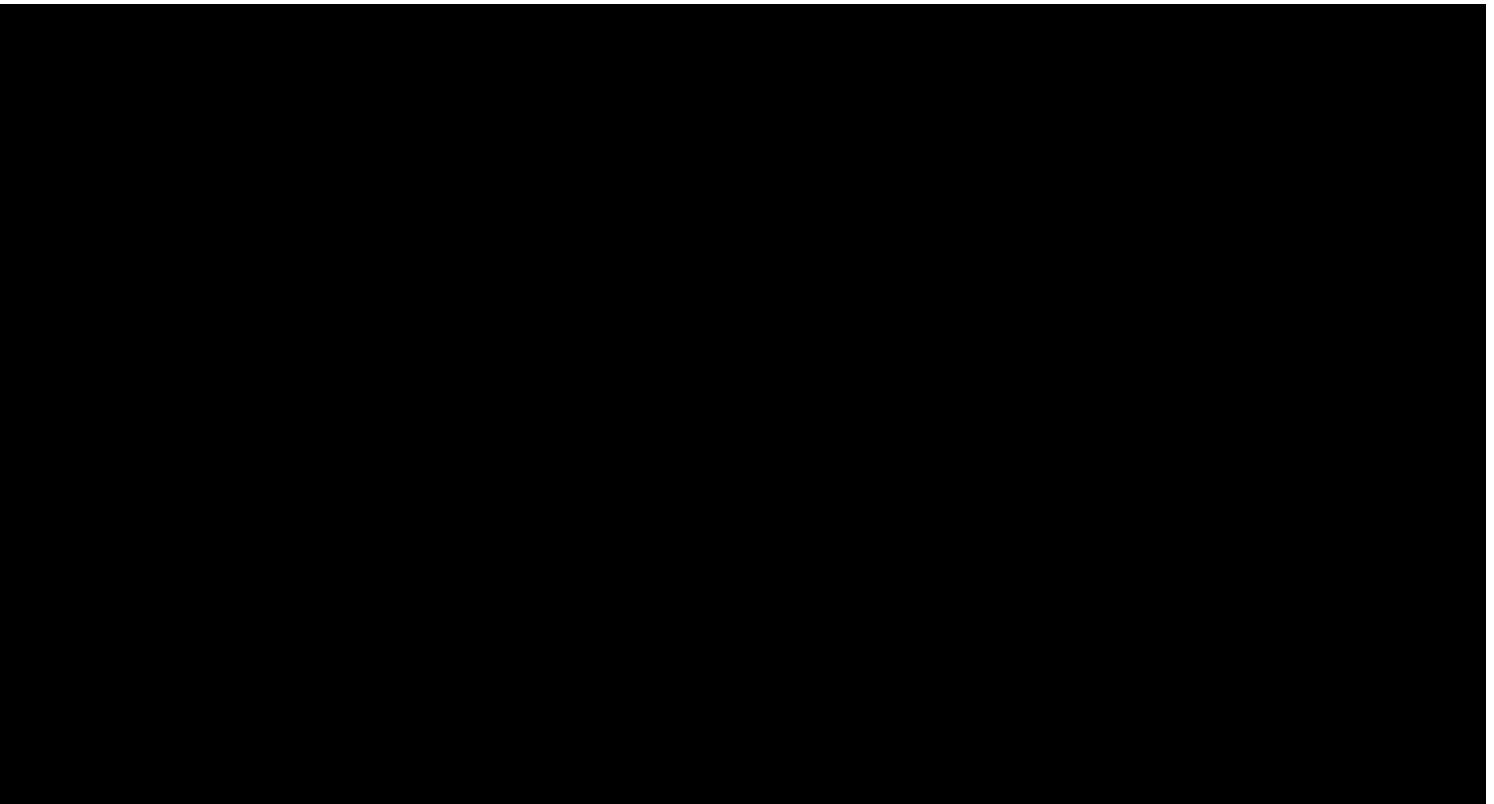

Hello and good afternoon, Mr. Alexander –

Thanks very much for your willingness to try the Box download again. I regret that I did not get the numbering convention correct – it should not have said “PRA 22-122”. May I go back to something I noted earlier on these requests? You indicated these are separate clients, so I want to do the best I can to separate PRA 022-123 (on behalf of David Daleiden) and PRA 022-124 (on behalf of Kristen Turner). Both requests seek IRB documents related to the use of human fetal, so there is overlap in the responsive documents. Could we maybe use a unique identifier, like “IRB Production” to signal that the records are responsive to both requests?

The Box folder (<https://ucsf.box.com/s/6uybli8itpi6tmffft0ppn3noe5ja1h0>) now has additional documents ready.

- PRA 022-123 Box Production 4.18.12 PDF. These are fetal tissue procurement records that are responsive to Mr. Daleiden's 022-123 request.
- PRA IRB Production 4.18.23 PDF. These are IRB records responsive to both requests.
- PRA IRB Production 4.6.23 PDF. These are IRB records responsive to both requests. These are the same records previously produced, but I am not sure I did a good job of communicating they are responsive to both requests.

I believe you know from previous UCSF PRA requests that we will work to get you and your clients all non-exempt records. My apologies that the roll out for 022-123 and 022-124 was a bit choppy at first – but as long as the Box delivery is working well for you, I think we will now have a routine for our rolling productions.
