UCSF has assigned tracking number 021-091 to your request of September 8, 2021, that was sent to Mr. Raymond Cardozo of ReedSmith: "... request is hereby made now for any records wherein there is mentioned or discussed or reported of an "extramural delivery" or "extramural delivery prior to demise" in the records of the Women's Options Centers. The timeframe for this request is January 1, 2015 to the present date."
