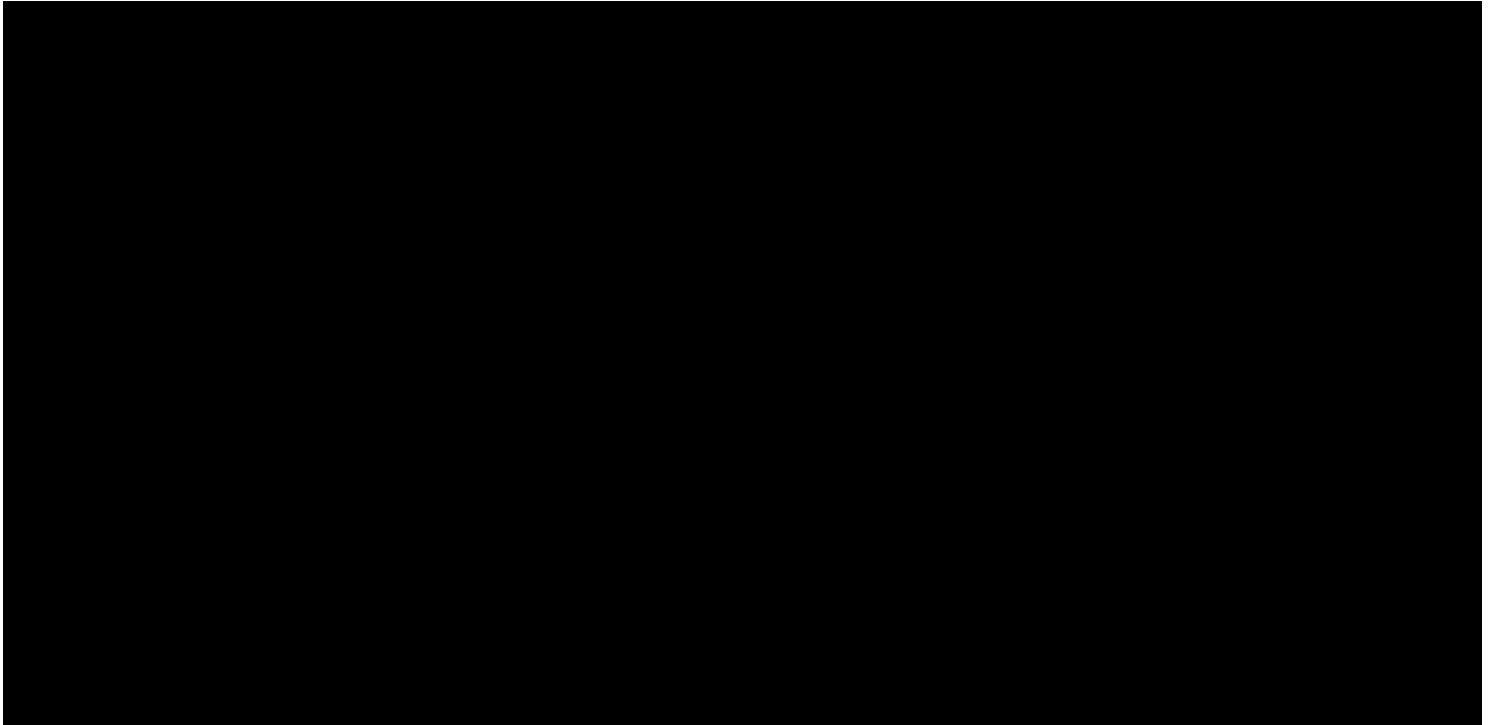

Hello and good morning Mr. Alexander. I hope this finds you well on a Friday.

UCSF has now completed the search for correspondence from those involved in executing the agreements. Dr. Linda Sawyer is no longer with the University. Drs. Martin-Holland and Lucey did not have any correspondence regarding the agreement (which were executed circa 2013, 2014 – 2017). From a procurement perspective, the University is unable to locate any communications. Regarding the administration of the program, the Bixby Center ([https://intranet.bixbycenter.ucsf.edu/training/training/kenneth\\_j\\_ryan\\_training.html](https://intranet.bixbycenter.ucsf.edu/training/training/kenneth_j_ryan_training.html)) would likely have communications regarding rotations in departments of OB-Gyn, but UCSF did not read the request as seeking clinic / student rotation information. Dear Ms. Gee,

Thank you for your letter of today's date.

Regarding your inquiry on my client's fifth request, we are somewhat handicapped in asking for a search of specific individuals who work or worked at the University on these projects as we do not possess that information. This includes the persons who executed the contracts whose identities were redacted by your office before they were sent to myself and Ms. Bukovinac.

Therefore I would like to amend the request as follows:

"Any official University of California San Francisco trustee and/or facility and any administrator or staff who works directly for the trustees or facility memorandums, e-mails, or other communications regarding Planned Parenthood, Planned Parthood Affiliates of California, or Planned Parenthood Federal of America."

My client is not interested (for example) in a University employee's mention of or an offhand comment about Planned Parenthood in an e-mail if that person / employee is **not** involved in the contractual relationship between the University and the Planned Parenthood entities or the Ryan Training Program.

They **would be interested** in this information by and between persons involved in the procurement department (or whatever that department is called) of the University even if these persons do not work directly for a trustee or facility member.
